Amendments #53 and #61 Are Needed to Advance Drinking Water Quality Statewide

The House of Representatives began considering amendments to the House Ways and Means FY23 budget yesterday, and debates continue throughout the week, so there is still time for you to let your State Representative know about your priorities and concerns.

For many Massachusetts residents, drinking water quality is a top concern. Through the Foundation's support of the <u>Private Well Program to Promote Public Health</u>, a Round 5 Synergy Initiative project led by RCAP Solutions, a number of personal stories of private well owners have emerged that demonstrate the need for the legislature to take action now:

- A single parent who is unable to work because of ongoing health issues with uranium levels four times the federal EPA maximum contaminant level in the private well
- A family experiencing gastrointestinal illness as a result of E. coli in the private well
- A homeowner discovering high levels of arsenic, radon, and uranium in the private well

 2. Call or e-mail your State Representative to ask them to**co-sponsor Amendments #53 and #61**. You can use language such as:

"I am contacting you today as a constituent supporting two important amendments that would advance health equity and strengthen drinking water protections in the House Ways and Means FY23 State Budget. Please cosponsor Amendment #53, Private Well Drinking Water Safety Treatment Loans, in order to expand the existing state Septic Repair Loan Program to enable low-income private well owners to access no-/low-interest loans to remediate contaminated private wells without further delay. Please also cosponsor Amendment #61, Drinking Water Quality For All, which would authorize the Massachusetts Department of Environmental Protection to develop evidence-based statewide regulations to ensure that drinking water from private wells is safe from contaminants such as PFAS, E. coli, arsenic, uranium, etc., as the current piecemeal approach of local regulations has resulted in inadequate and inequitable drinking water protections across the state. Together, these two amendments will help ensure that all Massachusetts residents have access to safe drinking water regardless of where they live or what their financial resources are."
